Koryu (Muso Shinden Ryu) may be taught if time and space permits. All styles and levels are invited to participate in the seminar. Those who wish to test must have: 1) AUSKF membership; 2) Permission from their instructor; 3) Ability to follow ZNKR standards for seitei iai. Students may apply to test for 2 dan and below. All students wishing to test for 1 dan and above must provide a copy of their current menjo at or prior to the time of the exam. A written test is also required for all candidates and must be submitted prior to the shinsa. Menjo fees will be collected following the examination and paid to AUSKF. Additionally, menjo fees are required for registration new ranks and will be applied towards


