TOURNAMENT RULES AND REGULATIONS

Kyu Divisions:

3 minutes, 2 minute extension, Hantei (Except semifinal & Final Rounds)

No Jodan, Tsuki or Nitto allowed

Individual Championships: (Yudansha) 5 Minutes, Unlimited extension

- For all kyu divisions, including adult kyu, the tsuki point will not be considered as a valid point.

- For all kyu divisions, including adult kyu, a participant may only use the chudan position to strike from. All points from other non-chudan kamae will not be considered as a valid point.

Jodan, Tsuki, and Nitto will not be allowed,

Hidari Do, (Gyaku Do) will be allowed in the following Kyu Groups.

5-4 Kyu, 3-1 Kyu, Adult Kyu, and Womens Kyu.

Womens Kyu (14 and older)

Womens Dan-4 minutes, 2 minute extension, Hantei, (Except Semifinals & Finals)

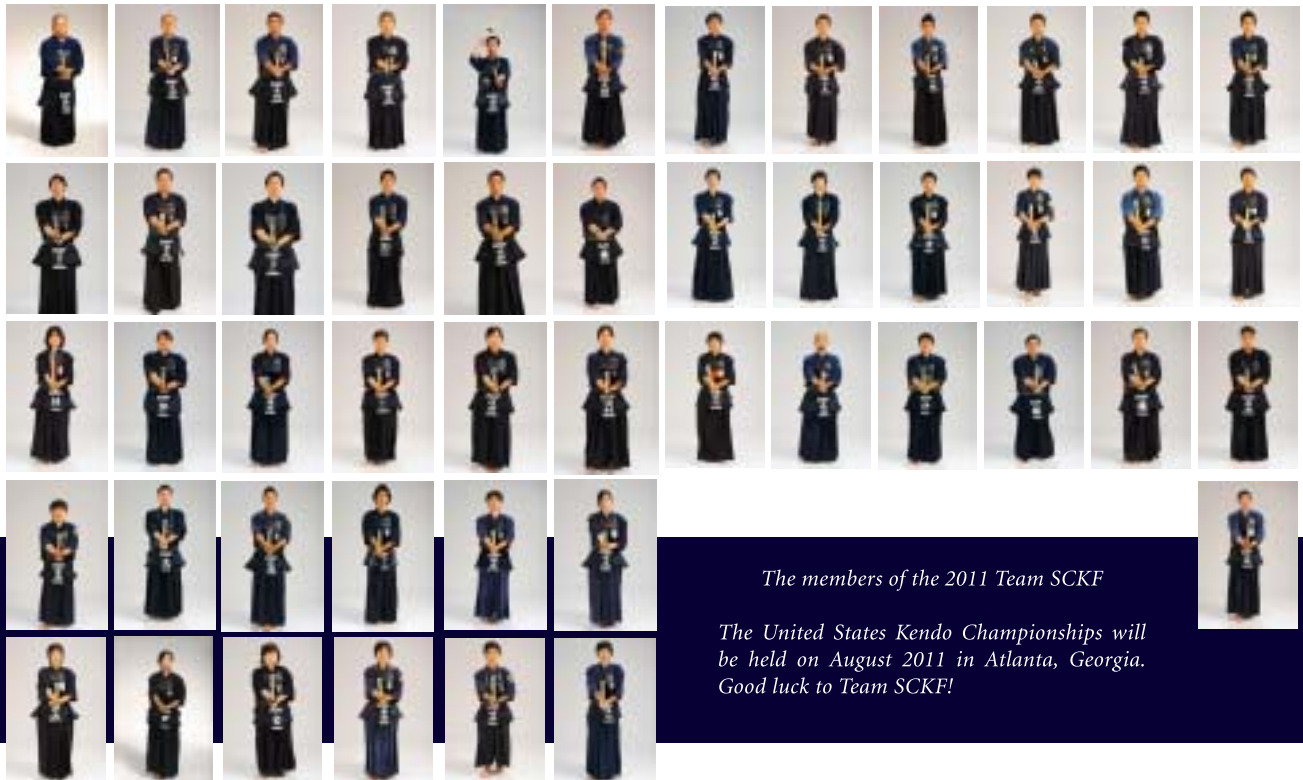
